

Kilpatrick Townsend Earns Sweeping Recognition in *U.S. News – Best Lawyers*® 2023 “Best Law Firms” Rankings

Firm Once Again Named “Law Firm of the Year” for Trademark Law

ATLANTA (November 3) – Kilpatrick Townsend & Stockton once again earned wide-ranging recognition in *U.S. News – Best Lawyers*® 2023 “Best Law Firms” rankings.
